## TEXAS ELITE F1 AND BRAHMAN FEMALE SALE

WHERE: Caldwell Livestock Commission: Caldwell, Texas

SELLING: All F1 crosses and any other suitable replacement type females, registered and purebred Brahman, Hereford, and Angus females. Select group of registered and purebred Brahman, Angus, Hereford, Brangus, Beefmaster, and Charolais bulls.

FEMALES: All females must be old enough to breed and not older than second calf or have their second calf at side. They must be in great condition (FAT). Only top quality females will be accepted.

BULLS: Accepting Brahman, Angus, Hereford, Brangus, Beefmaster, and Charolais bulls only of top quality. Sale management will screen bulls.

## PICTURES OF FEMALES AND BULLS MAY BE REQUIRED BY SALE MANAGEMENT.

REGISTRATION PAPERS: All original registration papers must be submitted along with consignment forms. Please sign the back of your registration papers.

CONSIGNMENT DEADLINE: Deadline to submit consignments is March 1, 2025. Forms will be available on our website: brokentrianglecattle.com, and caldwelllivestockco.com, but if you would like a form mailed to you, please contact Milton Charanza (979-450-8588). Please adhere to this deadline so that information on your cattle can be included in advertisements or website ads. Ear tags and cattle consignment form will be mailed when *Consignment Signature Form* is received by sale management. Place the sale ear tag in the left ear of your cattle. If you know how you want to group your cattle to be sold, please indicate that grouping on the form and mail or email the form back to sale management as soon as possible.

SALE CHARGES: A sale entry fee of \$10.00 per head for all females and \$25.00 per head for all bulls is required and is non-refundable. F1 and purebred females will be assessed a 7% commission on the gross sale price. Registered females and bulls will be assessed a 10% commission on the gross sale price. Additional charges on all animals will be assessed for Beef Check Off (\$2.00 per head), Brand Inspection (\$0.85 per head), breed association transfer fees, and Insurance (\$0.0040 of gross per head) and will be deducted from sellers proceed check. If any cattle are run through the chute

for any reason there will be a chute charge of \$20.00 per head in addition to any veterinarian charges that may be incurred.

PASS OUT FEE: Full commission will be charged on any cattle not sold. No cattle can be passed out after the sale. Payment of pass out commission must be paid before consignor can remove any cattle from Caldwell Livestock Commission after the sale. If you have a floor on your cattle, please discuss the price with sale management before the sale. All pass outs will be handled by sale management.

HEALTH REQUIREMENTS: Consignors will be required to submit an Official Health Certificate of the Texas Animal Health Commission (or State of Origin) issued by an accredited veterinarian for each animal consigned to the sale. The health certificate must be issued within 30 days of the sale date (March 22, 2025). If you are an out-of-state consignor, please have your veterinarian contact the Texas Animal Health Commission for up to date requirements to enter and sell cattle in the State of Texas.

Additional Health Requirements:

- No brucellosis or TB tests required.
- All cattle must have an RFID Tag and that number must be listed on the health certificate (along with the sale ear tag #).
- It is recommended by sale management, but not required, that all females be
  Official Brucellosis Calfhood Vaccinates. The vaccination tattoo must be
  readable in the ear and indicted on the health certificate.
- Indicate on health certificate if a female has a calf at side.
- Bulls must be virgin, fertility tested, and trich tested negative.

PALPATION REQUIREMENTS: Females must be palpated to be sold as bred and the approximate number of months bred must be listed on health certificate. Also list number of months bred on a blank ear tag and place it in the right ear of the female. All open females must be palpated to insure a sound, mature reproductive tract. Open or exposed females must be guaranteed by the consignor to be breeders. Pairs and bred females will be considered breeders without further guarantee. Buyer has until April 4, 2025 to have an accredited veterinarian check pregnancy status of bred females. A complete set of terms and conditions will be listed in the sale program to protect the consignor and buyer.

ARRIVAL: Please arrive at the Caldwell Livestock Commission no later than 3:00 p.m. on Thursday, March 20, 2025. If cattle need to arrive earlier than Thursday you must contact sale management to coordinate early arrival.

HAY/FEED: Hay will be available and fed to all cattle by sale management. Cost of hay will be determined closer to the sale date. If you prefer to bring feed, you will be responsible for feeding your animals and providing their feed pans. Sale management will water all cattle.

MISCELLANEOUS: At time of arrival please give sale management a list of the cattle sorted by groups the way you want them sold and their ear tag numbers. It does not matter how you load your trailer. Sale management will sort the cattle into their pens when unloaded.

Consignor checks will be mailed within 15 business days of the sale. Names and addresses of buyers of your cattle will also be mailed with the sale proceeds check. We hope to have a great sale, but as always, it will help if you contact your customer base and let them know about the sale and what you are consigning. Have your cattle in great shape and FAT. Good condition always results in higher premiums for your cattle.
