Sale Guidelines/Rules and Consignor Information

To consign cattle: Please fill out the enclosed consignment and signature form, sign it, and return by **Friday, October 30, 2020**. Email scanned copy to milton@brokentriplecattle.com or mail to: **Broken Triangle Cattle Marketing, 8969 County Road 410, Caldwell, TX 77836**. Call immediately to discuss your consignment(s).

Ear Tags: Numbered ear tags will be issued for each animal to be put in the left ear. Include this tag # on the health certificate, along with the metal tag #. **THIS IS A REQUIREMENT FOR SHIPMENT OUT OF THE STATE OF TEXAS.** A blank tag will be issued for any calves at side and the tag # of the dam will need to be written on the tag. Consignor will need to place a separate tag in the animal's right ear listing pregnancy status (in months only). Tag will need to be provided by consignor.

Breeding Status & Health Requirements: All cattle selling are required to have a health certificate issued by an accredited veterinarian and it should accompany the cattle upon arrival to sale facility. All cattle must have a metal ID Tag and this tag number must be listed on the health certificate. All females must be palpated and pregnancy status must be stated on health certificate. Any females less than 60 days bred will be sold as exposed. All open females must be listed as open and veterinarian must declare their reproductive tract sound. All bulls must be fertility tested, breeding age, virgin bulls with a breeding soundness exam and a virgin bull certificate signed by the consignor. In addition, all bulls must be trich tested negative.

PLEASE NOTE: THE SALE EAR TAG # ISSUED BY CALDWELL LIVESTOCK MUST ALSO BE LISTED ON THE HEALTH CERTIFICATE.

Cattle Arrival: All cattle should be delivered to the sale facility no later than Thursday, November 12, 2020 (no exceptions). A chute fee of \$5.00 per head will be charged to consignor for any animal that has to be run through sale chute for any reason. Hay will be fed and charged to consignor at cost. Consignors are responsible for supplying and feeding cattle grain.

Commission: Charged at 7% for commercial replacement females and purebred commercial females and 10% for registered females and bulls. A full commission will be charged for any pass outs. Additional charges include: Yardage Fee - \$2.00 per head; Beef Check-Off Fee - \$2.00 per head; Brand Inspection Fee - \$0.85 per head; Insurance - \$0.0040 of gross per head. Consignor checks will be mailed within 10 business days after the sale.
